CHAPTER 1

1.1 INTRODUCTION

This document serves to aid students in writing their honours projects / masters thesis in LaTeX. The document is to be used in conjunction with the guideline document as provided by the Department of Statistics and Actuarial Science and which is included in the file named Assignment Guideline.

In our experience, many students experience difficulties with the formatting of their reports. It will save you time if your document is in the correct format from the beginning. This template is designed to assist you in writing a report in the correct format as required by the Department of Statistics and Actuarial Science (the Department). The document is written in the format required by the Department and aims to give some practical advice along the way. The headings in this, the first chapter, give the student an indication of the structure of a typical first chapter. Students can adapt these according to their reports, whether it is qualitative or quantitative and whether hypotheses are included. Note that the table of contents does not refer to itself, i.e. it is not an item within the table of contents. The tabs running up to the page numbers do not have any leader characters, i.e. dots.




Figure 2.1: Neural Network Structure

2.9 MATRICES AND SIMULTANEOUS EQUATIONS

Here we have a very simple application of the case statement.

$$f(x) = \begin{cases} 3x + 5y + z \\ 7x - 2y + 4z \\ -6x + 3y + 2z \end{cases}$$

Matrices can be assembled by using the array statement, like in this example:

$$\left|\begin{array}{ccc} x_{11} & x_{12} \\ x_{21} & x_{22} \end{array}\right|$$
$$\left|\begin{array}{ccc} x_{11} & x_{12} \\ x_{21} & x_{22} \end{array}\right|$$

However, there is another statement, the matrix declaration, slightly easier to use:

$$\begin{array}{ccc} x & y \\ z & v \\ x & y \\ z & v \end{array}$$

The frames of the matrix can be displayed in several forms, by just changing the matrix declaration to vmatrix, Vmatrix, Bmatrix, Bmatrix or pmatrix, as shown ahead:



Step 1: Search for the necessary citation required. In this example the book *Statistics of Extremes* is used.




